

A Message from President, James Shillitto

WE HAVE A HOME

Brothers and Sisters, late this Spring our Union dream for a permanent home came true. For the past several years we have been saving our money in a dedicated Building Fund to buy a Union home that benefits the professionalism of the Members of Local 1-2. After the closing in late Spring on our new home on E. 36th St., between Fifth and Madison Aves., the real work has begun to transform the property into offices, meeting rooms and work-spaces for our growing needs as a Union and as workers in a utility industry that is undergoing profound changes on a daily basis.

We have hired an architect, we are reviewing contractor bids, and we expect that the work will be done in time to open a spanking, brand-new home that we own, and will be moving into early next year. Now, the money we spend will be for us and by us rather than expending all that cash on rent with no equity in hand.

Let's face it: in Manhattan, since it was first settled by humans, the name of the game has always been real estate, and now you, Members of Local 1-2, have a piece to call your own.





PLEASE TAKE NOTICE that, in accordance with Article VII, Section 2 of the By-Laws of Utility Workers Union of America, AFL-CIO, Local 1-2 ("UWUA Local 1-2"), the election of the UWUA Local 1-2 Election Board shall be held on November 17, 2022, at the times and place stated below.

NOTICE OF NOMINATIONS

PLEASE TAKE FURTHER NOTICE that, effective immediately, nominations are open for all twenty (20) positions on the UWUA Local 1-2 Election Board.

Nominations will be accepted through and including 5 PM EDT on Monday, October 31, 2022, in writing, either delivered in person at the Manhattan office of **UWUA Local 1-2, 5 West 37th Street, 7th Floor, New York, NY 10018**, or sent by mail to Secretary-Treasurer John Capra at the same address. Nominations may be delivered in person between the hours of 9 AM and 4 PM, Monday through Friday, inclusive, during that period. **No nomination shall be considered timely if it is received by UWUA Local 1-2 at the above address, in person, by mail or by any other means, after 5 PM on October 31, 2022.**

You may nominate yourself or any other eligible member or members in good standing of the Local. **IT IS ABSOLUTELY NECESSARY THAT THE NOMINATIONS FORM SHALL INCLUDE THE SIGNATURE AND EMPLOYEE IDENTIFICATION NUMBER OF THE PERSON OR PERSONS NOMINATED, SIGNIFYING THAT THE NOMINEE OR NOMINEES ACCEPT NOMINATION.** Be sure to include the names of the nominee or nominees as they should appear on the ballot, and also provide their addresses, home and work telephone numbers and private email address (DO NOT USE YOUR WORK EMAIL ADDRESS).

You are responsible to submit, upon request, proof of nomination, including proof of delivery of the nomination paper(s). Therefore, mail should be sent to Secretary-Treasurer John Capra at the above-stated address, by registered or certified mail, return receipt requested. If you deliver a nomination in person, please make sure you demand and receive a receipt for it.

Please note that no member of the Election Board is permitted to be a nominee for office.

Slate nominations and voting will be permitted. Twenty nominated members will constitute a complete slate; and only a complete slate will receive a "slate box" for voting

purposes. If you nominate members to run on a slate, your nomination must express that clearly; and all 20 members nominated must sign that they wish to run on that slate. Write the name of the slate clearly and indicate the order in which the nominees should be listed on the slate. If a slate name is not given, the nominees will not be listed as a slate. If you do not designate any particular order in which the nominees are to be listed, they will be listed in alphabetical order (by last name). No form of "ticket" or other grouping will be permitted other than complete slates.

Slates will be listed on the ballot prior to individual nominations. All individual nominees (i.e., those who are not included on a complete slate) will be listed in alphabetical order, by last name, on the ballot. If more than one slate is nominated, there will be a drawing at the UWUA Local 1-2 office (at the address stated above) on November 2, 2022, at 5:00 PM EDT to determine the order of placement on the ballot. Interested members in good standing, including nominees, are invited to attend and observe.

There is a nomination form on the following page which is provided for your guidance.

NOTICE OF ELECTION

The election of the Election Board (20 positions) shall take place by secret ballot on November 17, 2022, between 9:00 AM and 8:00 PM (ALL DAY VOTE) at Seafarers International House, 123 E 15th St., New York, NY. The election will be conducted and supervised by Global Election Services. Please bring your Union Card to expedite voting. The ballots will be counted immediately after the close of the voting period. Nominees and/or slate representatives may be present to observe; provided, however, that representatives of Global Election Services are authorized to limit the number of observers at any one time, in a reasonable manner, to maintain order and to avoid crowding. All observers MUST be members in good standing of UWUA Local 1-2.

The twenty (20) candidates who receive the highest number of votes, either as part of a permitted slate or individually, will be declared members of the Election Board; **provided however that no more than four (4) Election Board members may be from the same department of the same employer.** The Election Board will, together with the duly designated Impartial Administrator, conduct and supervise the 2023 Election of Officers of UWUA Local 1-2.

Rise Light & Power Announces Landmark Proposal to Replace Gigawatts of NYC Fossil Fuel Power Generation with Offshore Wind Energy

Owner of New York City's Largest Power Plant Proposes New Project to Meet New York's Ambitious Renewable Energy Goals, Subject to Selection in NYSERDA Offshore Wind Solicitation

*Rise's **Queensboro Renewable Express** (Queensboro) Includes Years of Thorough Surveys and Engineering That Confirm the Feasibility of Delivering Offshore Wind Energy to Ravenswood Generating Station*

*Queensboro, Part of Rise's **Renewable Ravenswood** Vision, Would Permanently Replace Fossil Fuel Generators, Preserve Good Union Jobs, Deliver a Historic Environmental Justice Victory, and Power Up to Two Million Homes*

Long Island City, New York – Rise Light & Power today announced another decisive step in support New York State's bold climate goals, debuting **Queensboro Renewable Express** (Queensboro), a mature offshore wind transmission project that will bring renewable energy to Queens and replace existing fossil fuel generation. This announcement follows the release of Rise's **Renewable Ravenswood** vision, which set ambitious targets to transition Ravenswood Generating Station from New York City's largest fossil fuel power plant to a hub of renewable energy. It also follows Governor Kathy Hochul's landmark announcement of New York's third offshore wind solicitation, which will procure at least 2 GW of offshore wind energy. Queensboro is an innovative solution to the most challenging problem facing the offshore wind industry: delivering energy from the Atlantic Ocean to consumers efficiently and cost-effectively. With years of surveys and engineering work already complete, Queensboro offers unparalleled project maturity for interconnecting offshore wind in New York Harbor.

Rise has been developing the Queensboro project for more than two years, completing 255 miles of geophysical surveys in New York Harbor to determine the safest and most efficient location for buried, submarine, high-voltage direct current (HVDC) cables. Multiple sets of transmission cables will bring up to 3.9 GW of offshore wind power from the Atlantic Ocean, through the Verrazano Narrows, Upper New York Bay, and East River to the Ravenswood site in Queens, avoiding any impacts to beaches, public streets, or other property. By landing the cables at Ravenswood – a 27-acre waterfront industrial site in Queens – the project will leverage existing infrastructure to lower costs and improve efficiency.

In addition to providing cost advantages, Queensboro allows the opportunity to permanently replace 1960s-era fossil fuel generation capacity and provide continued employment for Ravenswood's union workforce that has kept New York's lights on for decades. Queensboro, as part of the Renewable Ravenswood vision, has numerous advantages. :

Jobs, Training, & Local Economic Benefits – Queensboro will invest in local job training for the existing Utility Workers Union of America Local 1-2 employees, while also investing in offshore wind power. This would accelerate the transition to a clean and renewable energy economy while creating good-paying jobs, reducing greenhouse gases and combating climate change.

“Bringing new sources of renewable energy to Ravenswood Generating Station is a surefire way to ensure that UWUA Local 1-2 will continue to play a role in keeping the lights on,” said **Jim Shillitto, President of Utility Workers Union of America Local 1-2**. “By making investments to modernize and transition Ravenswood to clean energy, Rise will maintain electric reliability for New Yorkers and keep union workers at the forefront.”
